**RE: Statutory Requirement for “Trained & Competent” Overhead Crane
Operators (Course Code: OCOTC)**

The Workplace Safety & Health Act (WSHA 2006) had come into effect on 1st March 2006.

The Act stated that all Lifting Machine (Overhead crane, Gantry crane, jib crane, monorail hoist system) should be safe and without risks to health or to every person within those premises, whether or not the person is at work or is an employee of the Occupier.

It further adds that it is mandatory to “ensure that the person at work has adequate instruction, information, training and supervision as is necessary for that person to perform his work.”

Prosecution for Violation of WSHA 2006:

Max Fine Imposed for Individual: **S\$200,000** or **2 Years Jail**

Company: **S\$500,000**

In Jan-07, a company has been convicted of an **\$8,000** fine for failure to provide sufficient training to its crane operators.
